APPOINTED AS LICENSED MANUFACTURER FOR ENKEI ALLOY WHEELS

The Board of Directors of YHI International Limited (the "Company") wishes to announce that its wholly-owned subsidiaries, YHI Manufacturing (Singapore) Pte Ltd ("YHIMS") and YHI Manufacturing (Malaysia) Sdn Bhd ("YHIMM") (collectively referred as the "Licensees"), had entered into a License & Distribution Agreement ("Agreement") with Enkei Corporation ("Enkei").

Pursuant to the Agreement, the Licensees will be appointed by Enkei to manufacture under license "Enkei Tuning" brand of alloy wheels at YHI Manufacturing (Shanghai) Co Ltd, YHI International (Taiwan) Co Ltd, YHI Manufacturing (Malaysia) Sdn Bhd and YHI Advanti Manufacturing (Suzhou) Co Ltd (herein collectively referred as "YHI Manufacturing Facilities"). YHI Manufacturing Facilities will commence production from 1 July 2006. Enkei will be distributing these alloy wheels through their own global network. In addition, the "Enkei Tuning" brand of alloy wheels will also be distributed throughout YHI's distribution network.

Incorporated in 1950 in Japan, Enkei designs, manufactures and sells alloy wheels and has a wide geographical presence with factories in Japan, Thailand, Indonesia, Philippines, Malaysia, China and USA. Their main business is in the manufacture and supply of OEM alloy wheels to Japanese automobile manufacturers.

Our directors believe that this partnership with Enkei is synergistic and beneficial to our Group as it will further enhance our position as an integrated solutions provider of alloy wheels from design and development, manufacturing, to marketing and distribution.

The above transactions will not have any material impact on the Company's net tangible assets and earnings per share for the financial year ended 31 December 2006.

None of the directors or substantial shareholders of the Company have any interest, direct or indirect in the above transactions.
