On 27 August 2007, Seletar's interest in ordinary shares of YHI ("Shares") decreased from 36,000,000 Shares representing 6.16% of issued Shares to 27,000,000 Shares representing 4.62% of issued Shares.

Seletar's interest in Shares had changed from 15,000,000 Shares as of 1 Mar 2004 to 36,000,000 Shares as of 18 May 2005 as a result of a sub-division of every one Share into 2 Shares in Feb 2005 and a bonus issue of one Share for every 5 issued Shares in May 2005.

Seletar is an indirect wholly owned subsidiary of Temasek. Accordingly, Temasek is deemed by virtue of section 7(4) of the Companies Act ("Act") to have an interest in the 27,000,000 Shares owned by Seletar.

As of 27 Aug 2007, DBS Group Holdings Limited ("DBSH") also had a deemed interest in 108,000 Shares representing 0.02% of the issued Shares pursuant to dealings by its subsidiaries and/or associated companies. DBSH is an associated company of Temasek. Accordingly, Temasek is deemed by virtue of section 7(4A) of the Act to have an interest in the 108,000 Shares in which DBSH has a deemed interest.

As of 27 Aug 2007, Temasek therefore had an aggregate deemed interest in 27,108,000 Shares representing 4.64% of the issued Shares.
